New Features

This topic briefly lists the new features in this release of the product.

We added these features to Infor ERPLN:

- **Warehouse Mobility**
 1. **Project Pegging:** This feature allows the user to view and identify Project Pegs when performing transactions in WM.
 2. **Automotive Changes:** This feature supports Automotive Pick, Pack and Ship processes in WM.
 3. **Repetitive Orders:** This feature supports the recording of time and quantities against the repetitive orders.

- **Time Track**
 1. **Audit Trail Capabilities:** This feature is configured to keep the record of all the captured data, modified data and the processed data. Logs are saved for Clocked hours, Elapsed hours, Payroll processing activity and the Configuration record creation and edit.
 2. **New User Experience:** The look and view of the new designed transaction screens provide a user experience that is easier to use.
 3. **Clockable Lunch Enhancements:** The new parameters are introduced to make the reduction set features flexible in configuration and easier to prepare hours for processing.
 4. **Holiday Generator With Delete Feature:** This feature allows the user to delete multiple ABS records for both holiday and non-holiday report dates.

- **Shop Floor**
 1. This new module in Factory Track provides full touch-screen capabilities for monitoring and recording of all the shop floor related activities, including material-handling, biometric logins, the capture of machine and labor time data, the ability to assign job to operators and machine integration capabilities. See the LN Shop Floor help for the supported capabilities.
 2. **Biometric Support/Universal Clock-in:** This feature is used to support the biometric methods when logging into the Factory Track Shop Floor module.
 3. **Home Page Widgets:** This feature is used to deliver standard Mingle Widgets for Supervisors based on the Shop Floor module in the Factory Track application.

- **General Section**
 1. **GDPR (General Data Protection Regulation):** This is a regulation that requires businesses to protect the personal data and privacy of European Union citizens. To comply with the European Union General Data Protection Regulation (EU GDPR), Data Controllers and Data Processors can use the Data Anonymization by Employee

form to find and report the personal data that is held in the application for an individual.

2. Parameter extensions (Infrastructure): This feature addresses the look and view of the parameter groups and the related child parameter settings.
 3. Data Synchronization: Using this feature, you can synchronize the data in the Factory Track application.
 4. Messaging System: This feature helps in tracking the message system which sends messages to individuals, using the Factory Track application.
