Solution enhancements

Infor Global Financial Controller 10.4.5.0 contains these features and improvements:

Searchable dropdown list in all page

Provides the ability to specify text in the dropdown fields to filter selection.

Support for using the same document type as document reference in Rule-Document reference field

Instead of splitting two document reference conditions in the rule setup and rule script pages, the conditions where the same document reference is used can all be configured in the rule setup page.

Upgraded inbox status to support multiple rule output

Provides more details regarding processing status of input documents applicable to different rules.

Support expression within expression in JE template

This also includes support for text-type expression as source for Journal entry template value.

Simplified entity listing for custom documents without accounting entity

If the BOD metadata does not contain AE, user is not allowed to select an AE in Rule to simplify the choices.

Updated security

Provides a more secured application instance without compromising on performance.

Upgraded memory management for HealthCheck and Poller

Minimizes the risk of memory leaks.

Compatibility information

10.4.5.0 only applies to GFC multitenant deployment type.
