Infor Global Financial Controller 10.4.6.0 contains these features and improvements:

GDPR compliance requirements for cloud

IGFC cloud tools configuration is now GDPR compliant.

GDPR compliance: Purge feature for XML files

Provides a feature for scheduled cleanup of XML(BOD) files from the IGFC database. Meanwhile, ION record tables in IGFC are automatically purged once consumed.

Rule script editor value dropdown shortcut

This feature provides the user the ability to select from a list of IGFC rule script syntax, expressions, and the BOD names and attribute used to build the rule script.

Clone and refresh feature for cloud

Clone and refresh is a process used to migrate tenants across different or same cloud environments. These features allow duplication of tenant data into another tenant or a new tenant. Even files are included in the process of copy or backup.

BOD schema version 2.13.6 support

Added support for this BOD schema version affecting over 80 nouns.

Warning message updated to include the rule name applicable.

Provide on premise deployments with latest IGFC features and fixes.
