### Solution enhancements

Infor Global Financial Controller 11.0.0.0 contains these features and improvements:

#### Rule mapping feature

GFC now includes a new user interface for automating the creation of rule scripts. The attributes of the output document are displayed on the screen and the user can easily select and assign a value through a drop down menu. Assigning of conditions is also provided through this user interface.

#### Multiple rules activation

Select multiple rules to be activated simultaneously.

#### Logical ID pattern support for applications using Infor Messaging Service (IMS)

Applications sending BODs via IMS has a logical ID pattern that is different from applications that are sending BODs via ION I/O box. This enhancement allows registering entities with the logical ID pattern of IMS. GFC still supports entity registration of applications sending BODs via ION I/O box.

#### System requirements

GFC is now running in Java 8 and Tomcat 9 in compliance with Infor Technology requirements.

11.0.0.0 applies to IGFC cloud and on-premise deployments. New features may vary between the two versions.
