- 1 Refer to the applicable Infinium AM installation document such as *Installing Infinium AM Release 2.1*.
- 2 For important product and release-specific instructions, refer to the applicable release installation document. During the installation process, you can install the Web components to run the application on the Web.
- 3 If you plan to use modules from the Infinium Materials Management or Infinium Process Manufacturing suites with interfacing Infinium Financial Management modules, install the applicable interfacing modules before installing the Infinium MM and PR suites.

The interfacing Infinium FM modules are:

- Infinium General Ledger
- Infinium Payables Ledger with Infinium Purchasing/Payables Exchange
- Infinium Accounts Receivable
- Infinium Global Taxation
- Infinium Currency Management

- 4 A dependent application enhances or extends access to and use of data from one or more related database applications.
- 5 If you plan to use modules from the Performance Management or Self Service suites, you can install these modules anytime after installing their associated core applications.
- 6 The Infor HCM Infinium Self Service module is also referred to as the SHCM application.
- 7 You can install the Infinium Navigator files on a server accessible to users and install the reader on each user's personal computer. You can install the reader and the Infinium Navigator files onto each user's personal computer hard drive for direct access.
