To install the base solution, your server must meet these specifications:

- Windows Server 2016
- SQL Server 2016

The server must have a minimum of 8 GB RAM for a 50-user license. If your license is for more than 50 users, more RAM is required.

The applications require 450 MB of hard drive space.

If you plan to extend the solution with Infor ION or an ERP, then additional RAM and hard drive space will be required. Contact Infor Consulting Services for more information.

This software is also compatible with Windows Server 2019 and SQL Server 2019.
