Intended audience

This guide is for system administrator or professional services consultants who install and configure the Infor Reporting Platform.

Prerequisites

Due to changes in the platform for security, you should read *Preparing for the installation* in the *Infor Reporting Installation Guide for the Platform*.

The Infor Reporting 10.5 platform uses Infor Federation Services (IFS) claims for authentication and authorization. Depending on which security option is selected, Active Directory Federation Services (AD FS) may also be required.
