Cost roll up graphic change

The graphic showing cost roll up for bill of material has been changed, see attached.

Function key description changes for Control File Maintenance displays

Revised description of the function keys 10 and 24 used on Control File Maintenance displays now read:

F10=Reset defaults causes the fields to be reset with the text from NLSTXT.

F24=End causes the File Maintenance menu to appear and updates any changes you made.

F8 has been removed from Control File Maintenance display (AMDPDM3).

Run option selection for Quantity updated for AMEF43 display

The field description for Quantity has been updated to match the new run option selection of 7 or 8 on the Retrieval Selections-Costed-Single List (Select) display. The earlier run option selection was 5 or 6.

Time Basis Code clarification for code M

When M is used, it not only applies to minutes per piece, but it also applies to all time fields entered; all other time basis codes apply only to run machine and run labor.
